Updates were made with the exception of the comment relating to page 39, section 179 'To remove D and G', To remove H (b) and 'Question: Does there need to be a reference to reserve sites?'

N37/17 To receive an update from Colin Wilkinson, Plan-it X

This item was moved from item 6 to item 7 on the agenda.

CW reported that the next stages are:

The (Pre-Submission) Draft version of the Wolds Villages Neighbourhood Plan will be made available for consultation with residents and stakeholders for a minimum of 6 weeks. A summary of the Draft Plan could be delivered to all premises within the area to make residents and businesses aware of the consultation. The full version of the Draft Plan will be available for download from the Parish Council websites. These arrangements will be discussed in more detail at the next meeting of the Committee.

All representations and comments received will be considered by the Parish Councils and may be used to amend the draft Neighbourhood Plan. The Neighbourhood Plan will then be submitted to Charnwood Borough Council for publication and a further six-week public consultation will take place before it is sent to an Independent Examiner. Everything being well, the Examiner will recommend that the Neighbourhood Plan is submitted to a local referendum (with or without further changes). Charnwood Borough Council will arrange a referendum and, if the Neighbourhood Plan is approved by a simple majority of those voting, the Borough Council will adopt it.

Resolved: That CW will update and amend the document and recirculate updated draft.
